

#### GUARANTEE:

# (a) All products sold by SV Technologies are given under Functional Guaranteed & Warranty for a defined period from the date of dispatch of the goods.

#### The Guarantee however does not cover or extend to:

1. Damages and defects caused during transit from SV Technologies works to Buyer's place or

during internal shifts at the Buyer's place or from the buyer's place to any other place.

2. If the products are put to any use other than those for which they are intended.

3. If the products are used by unauthorized persons which term shall include the Buyer or his workmen or other person or representatives whether in the regular employment of the Buyer or not, who are not trained or competent to operate or use the products.

5. If the products have been resold by the buyers.

6. Natural wear and tear.

7.
